Due to limited space, the number of vendors will be limited. This application is due by May 31st accompanied by a non-refundable, one-half stall fee payment. The second payment is due no later than June 14, 2019. Failure to pay in full by June 14, 2019 may result in complete loss of market space. There is no guaranteed space for any vendor.



▣ *The Shakopee Chamber & Visitors Bureau shall review and approve all vendor applications before a vendor can participate in the Market. Space at the Market and the mix of items a vendor offers and vendor variety are some, but not all of the factors in determining approval. Preference will be given to those available for at least 7-12 of the weeks of the Farmers Market.*

▣ *During selection of a vendor, the Market shall not discriminate on the basis of race, color, creed, religion, ancestry, national origin, sexual orientation, disability, age, marital status, or status with regard to public assistance.*
